## ORDER:-

In the letter fourth read above, the Chief Engineer (Construction and Maintenance), Highways Department has sent proposals to take up new works to the tune of Rs,4770 crore under Comprehensive Road Infrastructure Development Programme (CRIDP), for the year 2016-17.

 In the letter fifth read above, the Government directed the Chief Engineer (Construction and Maintenance), Highways Department to send a revised proposal under Comprehensive Road Infrastructure Development Programme for the year 2016-17 for an amount of Rs.2500.00 crore.

- 3. In the letter sixth read above, the Chief Engineer (Construction and Maintenance), Highways Department has sent the revised proposals giving importance for widening of State Highways from Intermediate Lane to Double Lane and Major District Roads from Single Lane to Intermediate Lane and widening and strengthening of Other District Roads, bridges, culverts etc. He has furnished the list of works stating that the announcements made by the Hon'ble Chief Minister during the Budget session 2016-17 under Rule 110 for the works of Forming Bypass to Tharamangalam Town and Forming Rasipuram Bypass phase I part II have been included in the Comprehensive Road Infrastructure Development Programme 2016-17 at a cost of Rs.2500.00 crore and requested orders of the Government.
- 4. The Chief Engineer (Construction and Maintenance), Highways Department has stated that the works which were already sanctioned in the G.Os. first, second and third read above during 2015-16 for which financial allocation has been provided for the year 2016-17 are included in the proposal as follows:

He has also stated that amount of Rs.30.59 crore have been included in Comprehensive Road Infrastructure Development Programme (CRIDP) 2016-17 proposal for the announcements made by Hon'ble Minister for Public Works & Highways and Minor Ports, the work of "Improving flood protection arrangements in and around Chennai by providing additional Pump sets, Diesel Operated Generators, disposal drains in vehicular underpass and making provision of culverts and drains in vulnerable locations of the Highways to mitigate the flooding during monsoon". Orders for the said work have been sanctioned in the G.O. seventh read above.

5. The Government have examined the proposal of the Chief Engineer (Construction and Maintenance), Highways Department at para - 4 above in detail and accord Administrative Sanction for widening and improvement of State Highways, Major District Roads, Other District Roads, Other District Roads SCP and bridges & culverts etc. at a total cost of Rs.2256.16 crore (Rupees Two Thousand Two Hundred and Fifty Six crore and Sixteen lakh only) for 2549 No. of works under Comprehensive Road Infrastructure Development Programme (CRIDP), 2016-17 as annexed to this order. the Government in Highways and Minor Ports Department in the interest of expeditious execution.
