ORDER:-

In the reference first read above the Chief Engineer (C&M) has sent proposals to take up new works to the tune of Rs.2500 crores under Comprehensive Road Infrastructure Development Programme (CRIDP), (2011-2012).

2. The Government examined the above proposal and decided that the allocation under Comprehensive Road Infrastructure Development Programme 2011-2012 be capped at Rs.1900 crores. Hence in the reference second read above the Chief Engineer (C&M) Highways was requested to send revised proposal for widening and improvement of State Highways, Major District Roads & Other District Roads & Bridges at a cost of Rs 1900 Crores under Comprehensive Road Infrastructure Development Programme for the year 2011-12.

3. In the reference third read above, the Chief Engineer (C&M)Highways has sent the proposals giving importance for widening of State Highways from Intermediate Lane to Double Lane and Major District Roads from Single Lane to Intermediate Lane and widening and strengthening of Other District Roads, bridges, culverts etc at a total cost of Rs.1900 crores (Rupees One Thousand Nine hundred crores only) under CRIDP for the year 2011-12 against the budget provision available for the year as detailed below:-

4. The Government have examined the proposal of the Chief Engineer (C&M), Highways in detail and have decided to approve the proposal. Accordingly, the Government accord administrative sanction for widening and improvement of State Highways, Major District Roads, Other District Roads and bridges culverts etc at a total cost of Rs.1900 crores (Rupees One Thousand Nine hundred crores only) under the Comprehensive Road Infrastructure Development Programme for the year 2011-2012 as per outlay indicated in Para 3 above. The details of the works are annexed to this order.

5. The expenditure sanctioned in Para 4 above shall be debited to the following heads of account:-

(i) **State Highways:-**

5054 - Capital Outlay on Roads and Bridges - 03. State Highways - 337 - Road Works - JI. Comprehensive Road Infrastructure Development Programme - State Highways - 16. Major works.

(iv) **Special Component Plan (Other District Roads) :-**

5054 - Capital Outlay on Roads and Bridges – 04 - District and Other Roads – 789 – Special Component Plan for Scheduled Castes – JC Comprehensive Road Infrastructure Development Programme – Other District Roads – Under Special Component Plan – 16 Major works. (DP Code 5054-04-789-JC-1606)

6. The Chief Engineer (C&M) Highways, is directed to take up the works early and furnish monthly progress report to Government. He is also requested to ensure that the works sanctioned now are not included in any other Schemes.

7. The Chief Engineer (C&M) Highways is also authorised to make changes in the nomenclature of works or delete / substitute works without exceeding the total cost of the work, subject to obtaining prior approval of the Government.
